

## Important Information Summer & Fall 2025 and Spring 2026

## Fee Payment Schedule - Payment Deadline

NEW CHANGE: Beginning Summer 2025 semester, all students must have their financial aid finalized, a payment plan in place, or the balance paid in full by the payment deadline. If you are relying on financial aid, it must be fully processed by the payment deadline. If you are not using financial aid, a payment plan must be set-up or the full payment must be made by the deadline to ensure your classes are not impacted. A non-refundable \$25 payment plan setup fee is charged. Payments are typically divided between two to four equal installments. In addition to setting up a payment plan, a 10% downpayment is also required. Payments can be made prior to due dates, but a \$25 late fee will be charged on late payments. Please ensure that your payment plan, financial aid, or full payment is set up before the deadline to avoid any disruptions to your enrollment.
