Option 1: You may request your Verification of Non-filing Letter online by visiting www.irs.gov and selecting “Get My Tax Record”, and then “Get Transcript Online”. Not everyone is eligible for this option so if it does not work for you, you must use Option 2.

Option 2: Visit www.irs.gov/form4506t and complete an IRS Form 4506-T to request a Verification of Non-filing Letter. Complete these required fields: #1 - 4, check box #7 “Verification of Non-filing”, enter in #9 the date 12/31/2022, then PRINT, SIGN and MAIL (or fax) to the IRS. See the instructions page for address/number. Please allow the IRS ample time for processing.
