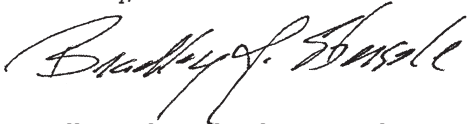

NURSING STUDENT PURSUES HER CALLING WITH SCHOLARSHIP SUPPORT

An accomplished athlete, Tori Wilson, a second year (4th Semester) Nursing student, began playing soccer when she was six. Determined to be the best athlete she could be, Tori's life revolved around training and practicing. All of that hard work paid off when she was offered a full ride athletic scholarship to a Division II college to play soccer and basketball. Six games into her first season, an unexpected injury and surgery ended her college athletic career, but opened the door to discover her true calling...to become a nurse.

"When I woke up from surgery, I was in excruciating pain and disoriented," said Tori. "The nurse that was taking care of me completely changed my life."

"I have been around hospitals a lot for various reasons, so I have seen the kind of care some nurses and physicians offer. They treat patients like a room number and nothing more. My nurse that day was the complete opposite. She was nurturing...she treated me with respect and was genuinely concerned about my wants, needs, and fears. That nurse's exceptional care made me realize that this is a career I want in my life."

In order to pursue her calling, Tori applied and was accepted into the Associate Degree of Nursing program at WSCC. Shortly after starting classes, she was notified that she was ineligible for Financial Aid, so she went to work applying for as many Foundation Scholarships as she could.

Tori is a recipient of multiple Foundation Scholarships including the Lynne Zoller Nursing Scholarship, the Tim and Jane O'Brien Nursing Scholarship, the Deb Patrick Nursing Scholarship and the President's Scholarship for Leadership Development.

"Receiving the scholarship support from the WSCC Foundation has helped to alleviate my concerns about paying for college and it allows me to fully focus on my studies," Tori said. "It is a good feeling to know that people believe in me as much as I believe in myself."

Tori currently works the night shift at Marietta Memorial Hospital and has recently joined the float pool to accommodate her class schedule and course work. Tori plans to continue her education by pursuing a Nurse Practitioner degree.

"I believe with a passion as strong as mine, I will never work a day in my life because I will truly enjoy my career."

Mr. Goehring, who for 43 years spent his career as an extractive metallurgical engineer working for Union Carbide and Eramet, said he wants to encourage aspiring engineers.

"Any direction I could give to aspiring engineers would be to include inquisitiveness, perseverance,

integrity and attention to detail in pursuit of your objective—and have a little fun along the way."

The Scholarship was created to encourage students to pursue an education in Engineering and Industrial Technologies in order to increase their employment opportunities in a successful and rewarding career, and to become a valuable and productive member of the local workforce. The Scholarship will be awarded annually to a deserving student that demonstrates

financial need and academic merit.

This is the second scholarship that Mr. Goehring has generously established in support of Washington State Community College students.

In 2013, Mr. Goehring created the Betty B. Goehring Memorial Scholarship in memory of his late wife. Bettie served the Union Carbide Corporation for 38 years in Administrative and Executive Secretarial functions.

Bettie's Scholarship was created to support the academic pursuits of students enrolled in the Business Technology Programs, to reward academic achievement, and to encourage degree completion.

LIBRARY TEXTBOOK PROGRAM HELPS STUDENTS SUCCEED

Considering that textbooks for one semester typically cost WSCC students \$600-\$800, WSCC Director of Library Services Mary Lou Moegling recognized an opportunity to help students minimize the cost of textbooks. She brought her idea to the Foundation.

With the generous support of Foundation donors, Ms. Moegling and her staff launched a program that offers textbooks for semester checkout and in-library use by current students.

Having the textbook loan option made all the difference to Megan Warner.

Megan, who lives in Lowell, is a Marietta High School graduate. She is an Education Transfer major at WSCC whose goal is a career in early childhood education.

Early each semester, Ms. Moegling and the library staff help students determine what books are needed for each class and find out if they are available through the library system.

As students and parents come to campus for orientation, Ms. Moegling encourages all to check into borrowing their textbooks from the WSCC Library or one of WSCC's 121 partner OhioLINK college libraries in Ohio for no cost.

All students participating in library research instruction sessions, are also made aware of this option and receive step by step instructions for accessing the system.

Ms. Moegling said, “We at the library are very grateful for the support of Foundation donors. Since 2010, the Foundation has provided funds that can be used to purchase textbooks for students to use at no charge.”

During the summer of 2016, Ms. Moegling received Foundation funds in the amount of \$3,000 for the purchase of 34 new textbooks which were made available to students immediately.

WILSON ANDERSON MEMORIAL SCHOLARSHIP ESTABLISHED

Jill Anderson's father was a remarkable man. Born in 1915, Wilson D. Anderson was a loving father and husband, a World War II Veteran, teacher, entrepreneur, and a man that couldn't resist helping out someone in need....no matter what.

"My father was a very dear, kind and loving person," says his daughter Jill Anderson of Marietta. "He was a gentle, unpretentious man that quietly exemplified what it means to be a father, not only to my brothers and me, but to all the young people whose lives he touched."

A strong believer in second chances, Mr. Anderson would frequently help out Jill's childhood friends by purchasing needed school supplies and clothing, including homecoming and prom attire.

Growing up in Spencer, WV, the Anderson home was constantly filled with visitors, especially the sibling's childhood friends, and was often referred to as the "Anderson Inn."

"My father was always willing to provide a warm place to stay," said Jill. "Our home was a refuge for anyone in need. He often gave our friends advice on topics from relationships to their futures, and always without judgement."

Not only was Mr. Anderson thoughtful in his generosity, he thoughtfully encouraged Jill and her brothers to be adventurous, go to college, pursue an education, and learn as much as they could about the world.

These are the characteristics that inspired Jill to establish the Wilson Anderson Memorial Scholarship. This Scholarship was created to recognize a student that is highly motivated, shows leadership abilities, and expresses a positive, caring attitude toward others. Non-traditional students, single parents, and others that need a second chance to succeed academically, are given strong consideration. The Scholarship will be awarded annually to a deserving student that demonstrates financial need.

DISTINGUISHED ALUMNI AWARDS

Two alumni were recognized as 2015 Distinguished Alumni Award recipients for the impact they are having on the community.

Jerry L. Bradford II '95 was honored for Outstanding Professional Achievement and Terrie Jean Lincoln '04 was honored for Outstanding Community Service. Both recipients addressed graduates during the Spring Commencement Ceremony.

Jerry, a 1995 graduate, earned his Associate of Applied Business in Microcomputer Applications at WSCC, then continued his education and earned his Regents Bachelor of Arts in 2012 from West Virginia University-Parkersburg.

After completing his associate degree, Jerry went to work for the Marietta Area Community Computing Center where he was able to use the knowledge he gained from WSCC to help members of the community develop computer skills. He also worked for the Adult Education Center at the Washington County Career Center at night while maintaining employment as an IT Technician during the day. Through perseverance and hard work, Jerry is now the Chief Information Officer at the Washington County Career Center. Jerry holds multiple Microsoft and Cisco professional certifications.

Terrie Jean, a 2004 graduate, received her Associate of Applied Science degree before transferring to the University of Rio Grande where she earned her Bachelor of Science in Public Administration in 2007. Following graduation, she moved to New York to continue her education and pursue a career in advocacy. Returning to Marietta, Terrie Jean, who is paralyzed from the neck down, founded a local group called Supporters of Disability Rights in the Mid-Ohio Valley which advocates for community members with difficulties in mobility and communications. She expanded her organization to develop a mental health program called Stomp the Stigma, as well as an anti-bullying program called Sticks 'n Stones, which provides a hotline for youth to confidentially report bullying.

In addition to supporting many local advocacy programs, Terrie Jean participated in drafting Ohio Senate Bill 130, which passed unanimously in the Senate, and once passed in the House, will designate the month of October as Disability History and Awareness Month.
